## **KAYUTA CRITTERS**

Invasive species of plants, animals, insects and microorganisms are among the most serious threats to native species, habitats and ecosystems within the five county area that define the St. Lawrence Eastern Lake Ontario (SLELO) Region. Invasive species interfere with many types of outdoor recreation. They reduce crop yields and interfere with harvest operations on local farms. Along public roads and highways, invasive plants restrict visibility and create roadside hazards. Invasive insects and diseases kill trees in forested areas as well as along community streets. The economic impact of invasive species in the United States alone has been estimated at 120 billion annually. Local communities have been challenged with controlling invasive species or remediating their impacts at costs ranging from several thousand to millions of dollars.

The partners of the St. Lawrence Eastern Lake Ontario - Partnership for Regional Invasive Species Management (SLELO-PRISM) invite the general public to attend one or more of the following information sessions to learn about invasive species in the region including their ecological impacts and their impact on local economies. Information regarding the SLELO-PRISM, Invasive Species and individual involvement will be presented.

Who should attend? The general public, elected officials, highway personnel, sportsmen and women, boaters, gardeners, landscapers, hikers, birders, photographers, farmers, campers and other interested persons are encouraged to participate.

## **Boater Safety Course**

KLIA sponsored a Boater Safety Course this year and it was held on June 9, at the Forestport Town Hall. Lt. Jim



McCarthy OCSO of the Oneida County Sheriff's office proctored the class and acknowledged the KLIA for providing refreshments and offered membership applications to residents. About 25 students attended and about half were from the Kayuta Lake area or close by.

There are also many classes scheduled around the rest of NY state. It is always a good idea to review the NYS boating regulations and to share them with all members of your family and guest that will be boating on Kayuta Lake. Increased use of the lake, especially on those gorgeous holiday weekends can add to the potential for scary incidents and injuries. Please be mindful of the "rules of the road". Knowing the requirements and being equipped to handle emergencies is each boater's responsibility.

Please continue to be respectful of the speed limits especially in the areas of Dustin Rd. and Ebert's bridges as well as the railroad trestle. If you see speeders, kindly remind them to decrease their speed and reduce their wakes. Congestion and blind corners in these areas can create dangerous situations that unsafe speeds can greatly compound. Enjoy the summer and stay safe!

## **DAM AND WATER LEVEL**



John Longway from Algonquin Power Company reported that they had a rather large meeting on the 15th of May with Algonquin and several contractors to discuss the scope of work and to obtain some bids on the concrete repairs. As of this time he has no scope of work and/or schedule for when the repairs to the dam will be approved or started. He believes that is up to John Weiss/TPI to make that determination.

As of last fall, John and another Algonquin employee had found and stopped the major leak that was going through the dam. They used a tarp and around 600 sand bags to plug the leak. The current plan (as far as John knows) is to use a coffer dam to dry up the area along the upstream right abutment wall so they can inspect and figure out how best to repair the damaged and leaking area. There is also a ton of small crack repairs along the crest and toe of the dam that need to be done along with reinstalling a bunch of rocks and repointing them along both abutment walls.

Currently the Lake level has been 1141.70. There is a FERC inspection scheduled for the week of June 12th, so this Friday he will be changing the lake level to 1141.60 in an attempt to dry up the dam for the inspection. After the inspection he assumes hopes to raise it back up until the work has been approved and they get started on it.

Until he is told and the proper permits are obtained, he can not take the lake any lower than 1141.47. He does not know if the lake will be lowered any more than that to complete the planned repairs.

KLIA will provide updates as they are made available.

## **SEPTIC SYSTEMS**

The usual poop... Local codes enforcement officers can issue the required permits for updating your septic system. All new and/or replacement systems must be designed by a licensed engineer and seepage pits/dry wells can no longer be installed as new systems. They are legal until they fail and must then be replaced with the appropriate engineer designed system, as location and soil conditions dictate.

For those who wish to test their septic systems to be sure they are not leaching any waste into the lake, test kits are available at the Spring and Fall meetings or contact any of the board members. Kits are \$4.00 each.

## **BUOYS ON THE LAKE**

Last season, buoys were added to mark dangerous areas of the lake. Either through the movement of ice or just missing the target, some buoys may be askew from where they should be. We've received reports that the two red and green buoys closest to Ebert's bridge may be off the mark a bit and the area between them is surprisingly shallow. Some have found that the area just outside the red buoy is a bit deeper. Please use caution and familiarize yourselves with all possible hazards at slow speeds.

We are in the process of trying to contact the authorities to see if the placement of buoys can be improved as problems are found.

## **FISH STOCKING UPDATE**

As per our discussions at the 2010 Fall meeting, we held off on stocking bass until we could get a survey of how well the current population is doing. We were concerned that the state stocking of tiger muskie at the rate of 1000/year would kill off newly stocked bass. At our request, the state did not stock tiger muskie in the fall of 2010 or throughout 2011.

On 11/28/11 Dave Erway of the NYS DEC Region 6 contacted Peter Bolos and informed him that the State will conduct a fish survey for us this summer (2012). I will follow up on this with information as it is made available.

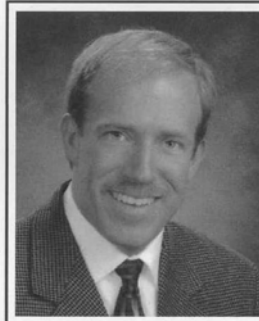

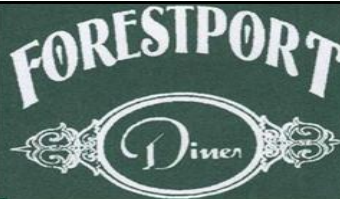
